The actual exercise price of each warrant is \$2.03 less the dividends per share declared by the company with a record date between 15 November 2021 and the announcement of the 18 November 2022 exercise price. Dividends totalling 3.67 cents per share have been declared to date and there are three more dividends expected to be declared in the remaining period up to the announcement of the 18 November 2022 exercise price.
